- To practice good stewardship of all our resources, including our people and our buildings

Endowment Fund Distribution Rules:

- 1. A minimum of 20 percent of the annual distribution shall be allocated and expended for the mission of Salem Lutheran Church, the Evangelical Lutheran Church of America and the Saint Paul Area Synod at home and overseas. Any income from this fund used towards the General Fund of Salem Lutheran Church shall not exceed 10% of General Fund expenses.
- 2. A minimum of 20 percent of the annual distribution shall be allocated and expended for outreach into the community including, but not limited to, Salem's Pastor's Emergency Fund, educational, social service and health care agencies, agencies specializing in the care of the needs of the poor and disadvantaged infants, children and the elderly including hospice; to institutions and agencies to which this congregation relates.
- 3. A minimum of 20 percent of the annual distribution shall be allocated and expended for (major property needs, debt reduction, or building programs of Salem Lutheran Church for items not ordinarily included in the annual operating budget.
- 4. The remaining 40 percent of the annual distribution shall be distributed by allocation to any one or among all of the above designated areas in any proportion as determined by the Committee members, upon the approval of the Church Council, for the purposes of enhancing the benevolent mission of Salem Lutheran Church.
